Graph 1 : Face Value of Issued Securities by GoG, BoG and Cocoa Board, 2015





Graph 3 : Pre-Negotiated Trades, January – August, 2015







Graph 5 : Monthly Repo Rates (%), January – August, 2015








Graph 8 : Volume Traded, January – August, 2015


