Graph 1: Face Value of Issued Securities by GoG, BoG and Cocoa Board, 2015



Graph 2: Interest and Maturity Payments, 1Q2015 – September, 2015



Graph 3: Pre-Negotiated Trades, January -September, 2015



Graph 4: Distribution of Outstanding Debt Securities, January – September, 2015






Graph 6: Monthly Repo Rates (%), January – September, 2015



