Graph 1: Face Value of Issued Securities by GoG, BoG, and Cocoa Board, 2015



**Graph 2 : Face Value of Issued Corporate Debt, 2015** 






Graph 4: Pre-Negotiated Trades, January - November, 2015








Graph 7: Monthly Repo Rates (P.A. %), January - November, 2015



