#### Section One: Debt Market<sup>1</sup>

#### **1.1 Accounts Opened**

The number of new accounts opened by both foreign and local investors increased from 22,195 during the first quarter to 22,930 in the second quarter. As at the end of the second quarter the total number of securities accounts registered by CSD stood at 601,962. Table 1 below provides further details on the total number of new investor accounts opened for each month.

#### **1.2 Issued Securities**

The value of issued securities declined by about 17% from a value of about GHS 10,342 million during the first quarter of 2014 to about GHS 8,623 million for the second quarter. Out of GHS 8,623 million of securities issued for the second quarter, Government of Ghana, Cocoa Board and Bank of Ghana issued about 94%, 4% and 2% respectively as indicated in table 2 below.

The total value of bids submitted during the various auctions held in the second quarter was GHS 9,310 million as against a target amount of GHS 8,708 million set by the three issuers (Government of Ghana, Bank of Ghana and Cocoa Board.

The number of securities issued decreased from eighty five (85) in the first quarter to sixty two (62) during the second quarter. Government of Ghana, Cocoa Board and Bank of Ghana issued

fifty four (54), one (1) and seven (7) securities accordingly as captured in table 4 below. A total of 261,995 bids were submitted at the various auctions by Primary Dealers. Out of 261,995 bids submitted, 261,810 bids were accepted while 85 bids were rejected.


During the quarter under review Barclays Bank issued a 91 Day corporate bill. The total value of corporate bill issued by Barclays Bank was GHS 30,779,428.



#### 1.4 Holdings of Investors

The total value of securities held by the Depository on behalf of various investors in the debt market was about GHS 25,086 million during the second quarter ended. Foreign investors owned about GHS 6,723 million forming 27% of the total value of securities outstanding during the end of the second quarter. Compared to the first quarter the value of securities held by foreign investors increased from a value of about GHS 5,791 million in the first quarter to about GHS 6,723 million during the second quarter. Table 9 below provides further information on the ownership composition of outstanding securities as at the end of June, 2014.



An amount of GHS 11,534 million was paid to 325,500 investors as interest and maturity proceeds during the second quarter representing an increase of about 9% over an amount of GHS 10,521 million paid to 272,340 investors as maturity and interest payments during the first quarter of 2014. Out of the GHS 11,534 million paid about 93% and 7% represented maturity and interest proceeds respectively as indicated in table 10 below.

#### 1.6 Over-the-counter Trades (OTC)/ Pre-negotiated Trades




# 1.8 Repurchase Agreement (Repos)

The repo market recorded 2,496 repo transactions for the second quarter ended as compared to 2,232 repo transactions recorded in the first quarter of 2014. The collateral value and the repo value for all repo transactions undertaken during the second quarter were GHS 47,538 million and GHS 32,432 million respectively. The repo market recorded an average repo rate of 19.71%, 22.96%, and 23.19% for the months of April, May and June respectively.


